Position Profile: The Saskatchewan Health Authority, Swift Current is looking for a pediatrician to join our exceptional physician compliment in Swift Current, Sask. The position would require clinical services, out-patient services and emergency coverage. The successful candidate would require to work with one other pediatrician providing the services required. This opportunity is a contracted position and the remuneration for call requirements is paid separately through the SMA specialist program.

Currently the call requirements 1:2. Those participating in call are reimbursed as part of the Specialist Emergency Coverage Program.

The Saskatchewan Health Authority (SHA) is dedicated to learning and is a partner in the growing educational needs of medical students and residents from the College of Medicine, University of Saskatchewan. Members of the department are eligible for appointment to the faculty of the College of Medicine, University of Saskatchewan, and take part in academic services including teaching of undergraduate and postgraduate learners.

Swift Current is a city of 17,000 people serving approximately 50,000 people in the surrounding area. We are located a short drive from larger Canadian cities (Calgary, Saskatoon, Regina). Arts, sporting events, and outdoor activities (camping, hunting, and fishing) are major recreational pursuits. To the west of Swift Current are the Cypress Hills, an area known for its geological and ecological rarity. To the northwest are the Great Sand Hills, which encompass a 1900 km² area, one of the largest of its kind in Canada. To the east is Grasslands National Park, which serves to protect one of the country's only remaining areas of mixed prairie grassland. Finally, north of Swift Current is the Saskatchewan Landing Provincial Park, which straddles the west end of Lake Diefenbaker and offers ample opportunity for boating and fishing. The city itself is very family oriented and offers a safe and relaxed lifestyle with all the amenities of a much larger city. The Saskatchewan Health Authority: The SHA is the largest organization in Saskatchewan, employing over 44,000 employees and physicians responsible for the delivery of high quality and timely healthcare for the entire province. This individual should be a team player, be able to interact effectively with patients, colleagues, staff and management, and function well in a high volume environment with a commitment to provision of high quality patient and family centered care.
